

**MARION COUNTY FAIR**  
**Tough Truck Contest Rules**

**7:30 PM, Monday, July 3, 2023**

- Any 2 or 4 W.D. truck qualifies as a tough truck. The truck must have workable seatbelts and the driver, and if present, passenger is required to wear a helmet. In addition, the driver must also have their driver's license on hand.
- Running order to be determined day of show.
- There will be no deep mud pits – track will be built for fast lap times.
- Long jump winner pays \$200.00. You must go over jump at the end of the track.
- Double entries are permitted. There will be an entry fee for each entry.
- Beer will be sold in pit area. However, no beer or alcohol may be carried in. Strictly enforced!
- Entry fee is \$25.00 per entry. Rider fee is \$10.00. NO REFUNDS rain or shine.
- There will be 2 classes. Mod and stock.
- Modified class rules – Modified class is open to any truck, SUV, Jeep, car or other race vehicle. No ATV's or UTV's allowed. Off Road Buggies and Tube Frame Vehicles allowed. Any DOT tire allowed (no paddle tires). Any suspension, driveline and drivetrain allowed. Any engine allowed. Turbos allowed, other power adders such as Nitrous, Superchargers, etc. are not allowed.
- Stock class rules – Stock class is intended for vehicles that are factory OEM stock. Trucks, SUVs, Jeeps and/or cars are allowed. No ATV's, UTV's, Buggies etc. 2 wheel, 4 wheel and all-wheel drive vehicles allowed. Any stock class vehicle must maintain a stock firewall, stock for that year/make/model engine (no power adders of any kind), stock suspension and stock driveline. Any vehicle deemed by Marion County Fair officials to have a significant performance advantage may be disqualified from earning prize money.
- Payouts will be given for the top 3 spots and the longest jump in each class.  
1<sup>st</sup> - \$500 2<sup>nd</sup> - \$200 3<sup>rd</sup> - \$100
- Longest jump \$200 for both classes  
First and second place winners will receive a trophy.
- First come first serve. The Fair Board reserves the right to close entries at any time.
- Drivers' meeting will take place 30 minutes before the start of the show with final rules
- Driver only gets in free.
- Anyone under the age of 18 must have parent signature on the Release and Consent form and parent must be present.
- The judge's decision is final!
